The Manager, ST.Gregorios English Medium School
Kaipattoor as per letter Ist cited has submitted the applicat-
ion and connected documents to accord sanction for obtaining
NOC from Government which is required for obtaining affili-
ation from CBSE Board. As per the letter second cited the
Manager has reported the matter before the Hon'Minister
for Education, Kerala and he inturn directed that steps
will be taken to reach the connected file before him.
In accordance with the above I have conducted spot verification
on 16-12-2000 and furnished a detailed report as follows.

The ST.Gregorios English Medium School, Kaipattoor
owns and Managed by ST.Gregorios Charitable Society of
St.Ignatious Orthodox Church, Kaipattoor which is a registered
Society Vide No.P.254/2000 before the District Registrar
Pathanamthitta.

The School is situated in 2 Acra 61½ cent land
in Survey No. 314/13 B1, 314/12-3, 315/5B, 300/12, 301/3-1,
301/5A, 301/3G in Vallicodu Village. The Village officer
Vallicodu has issued a Certificate to the above effect

and the Management has remitted the tax on 23-11-2000
vide-Receipts No.17 @ Rs. 51/- + Receipt No.18 @ Rs 59/.

At the time of my visit there are classes from
Standard I to VI are functioning in the above school. The
roll strength of pupils in various classes are as follows:

The above classes are conducted by well qualified
hands under the leadership of Mr. P.M. Joshua, Principal.
The details of qualification possessed by the teachers are
enclosed with the application.

The accomodation is sufficient to conduct the above
class division and have facilities when additional class
division are to be opened in future. The school Management
have obtained fitness certificate from concerned authority
regarding the buildings.

The school is equipped with sufficient furniture.
A well established library and laboratory are functioning
in the school. The Medium of instruction is English, besides
which they have agreed to teach Malayalam as a compulsory
subject.


The water supply and sanitary condition are adequate
for providing drinking water, Public Health respectively.
The District Medical Officer, Pathanamthitta has issued
certificate on this account.


The Educational Society has declared that the
admission to the schools will be opened to all without any
discrimination based on religion, caste creed or colour.
The society have enough financial stability for the smooth

functioning of the Institution. There are no Educational Institution under CBSE Pattern functioning with a radius of 5 KM from this Institution.

In the above circumstances, I may recommend to issue NOC to the school for affiliation to Central Board of Secondary Education New Delhi. The application and supporting documents in triplicate are enclosed herewith for necessary action.
